About the Covid-19 Vaccine

All children aged 5-11 yrs will be now be offered the first dose of the Pfizer/ BioNTech Covid-19 vaccine.

The COVID-19 vaccination will reduce the chance of your child suffering from COVID-19 disease. It may take a few weeks for their body to build up some protection from the vaccine.

Like all medicines, no vaccine is completely effective – some people may still get COVID-19 despite having vaccinations, but this should be less severe. Further information is available on symptoms on NHS.UK.

The vaccines do not contain organisms that grow in the body, and so are safe for children and young people with disorders of the immune system. These people may not respond so well to the vaccine, but it should offer them protection against severe disease.

Side effects

Like all medicines, vaccines can cause side effects. Most of these are mild and short-lived, and not everyone gets them. With the vaccine we use in under-18s, side effects are more common with a second dose.

Very common side effects include:

- painful, heavy feeling and tenderness in the arm at injection site
- feeling tired
- headache
- general aches, or mild flu like symptoms.

The above can be safely managed by plenty of fluids, home remedies such as Paracetamol and/or Ibuprofen (following the dosing instructions) and moving the arm. They usually resolve within 24-48 hours.

Less common side effects:

Following administration of Pfizer vaccine to protect against Covid 19 there have been very rare reports of the following side effects, these have usually occurred a few days after a second dose:

- Shortness of breath
- Chest pain
- Feelings of having a fast beating or pounding heart

Most symptoms are short-lived and will resolve spontaneously with some rest and simple treatments. However, should your son/daughter experience any of these symptoms, and you are concerned, please contact your GP or NHS 111 and explain that he/she has recently been vaccinated with Pfizer vaccine. Covid-19 Vaccine FAQs

Where can I find information on COVID-19 vaccination for children and adults?

Where will the vaccinations be given?

COVID-19 vaccinations for children aged 5-11 will commence from Early March 2022. If your child attends Medina House School, St George's School or St Catherine's School you will be provided with the date of your child's planned school session in advance and you will be asked to complete a consent form.

If your child attends a mainstream school site or is educated at home, you will be invited to book into a designated session being held at a local Family Centre on the island.

The number to book is **07876230718** . Lines are open 9am – 6pm Monday to Friday

The booking line is open for all children aged 5-11 identified as being at high risk if this is preferred over the scheduled school session.

Who will be giving the vaccine to the children?

The programme will be delivered by an NHS commissioned School-aged Immunisation team (SAI) and vaccination centre team which will include nurses, healthcare support workers, administrative staff, and other associated professionals who specialise in the delivery of school age vaccinations and COVID-19 vaccinations. The team will administer the vaccination according to nationally agreed standards. Staff are appropriately qualified, trained (including in safeguarding) and experienced in vaccinating children and young people. Staff administering the vaccine will be wearing appropriate personal protective equipment.

How will the SAIS provider team identify the children to be vaccinated?

The consent form will be either emailed to parents and carers of all eligible children via your GP or sent via post from your GP for you to complete for each individual child who is eligible for vaccination. The form will need to be completed at least 48 hours in advance of your child's school session to allow time for the clinical nursing team to triage and ensure that your child can receive the vaccination safely. If you do not wish for your child to be vaccinated, non-consent can also be provided on the same form.

The team will then have a list of all children for whom consent has been received in advance of the immunisation session.

If you choose to bring your child to a booked appointment at a family centre please bring the completed consent form with you.

Handy tips for preparing your son/daughter for COVID-19 vaccination

- Please ensure you inform us if your son/daughter has had a confirmed positive PCR test since you provided your consent or 12 weeks or less before the planned vaccination.
- Encourage them to have breakfast and drink regularly throughout the school day.
- Ask him/her to wear short-sleeved and loose-fitting shirt to allow us to be able to get to the top of his/her arm. The injection is usually given in the arm they do not write with.
- If he/she is known to suffer with severe needle phobia, or prone to fainting please speak to school as we can arrange for your child to be vaccinated earlier in the day.
- Help them with strategies for staying calm during the vaccination – it's natural to worry but we want your son/daughter's arm to be as relaxed as possible.
- Let your child know what's going to happen in simple language – for example, "you may feel a sharp scratch that will go away very fast".

What about those children turning 5 years of age within the school year, after the date of the vaccination session?

We will offer a vaccination to all children aged 5 years and over on the day of the school visit.

We will also offer this via the Family Centre's, or a wider community offer to the following groups too - this will help to ensure that the following pupils can access the vaccine:

- those turning 5 years after the session
- those who were absent from school on the day of the 1st session
- those who have had a COVID-19 infection over 12 weeks ago
- those who subsequently change their minds, or take longer to reach a decision

If you would like your child to attend one of the local community sessions these are the required actions:

1. Book an appointment via the booking phone line for your child – the details are above
2. Complete the consent form attached and bring it with you to the session; we encourage you to make this decision together with your child/children where possible
3. Please ensure your child's NHS number is completed on the form <https://www.nhs.uk/nhs-services/online-services/find-nhs-number/>

4. Please write your child's school name or identify that they are home schooled at the top of the consent form.
5. A reminder that if your child has had COVID they will not be able to access a vaccination for 12 weeks after their confirmed status – this is a change to the previous 4 week guidance.
6. Please ensure that your child attends the session either with yourself or somebody with parental responsibility.
7. In order to make the vaccination process easier for your child please ensure they have eaten before they come along, that they bring a drink with them and if possible that they are wearing short sleeved clothing.
8. Please bring with you your child's completed consent form.
